<p>Transport East Strategy and Public Consultation</p> <p>Esme Yuill provided analysis on the completed consultation for the draft transport strategy and investment and delivery Programme. Slides were shared (see below) and highlights included:</p> <ul style="list-style-type: none"> • 586 consultation responses, 118 from stakeholders including LEPs, MPs, transport operators and energy groups. • Strong level of support for TE vision and approach. • Challenges raised around existing public transport provision and desire to see improvements both in rural and urban areas • Concerns raised around sustainable growth of the region <p>Next steps and endorsement The consultation closed on 30th January with analysis being completed during February. Transport East Business Plan

Andrew Summers guided members through the draft business plan, seeking endorsement for the three-year plan and the detailed work Programme for 2022/23 set out in appendix 1.

It was noted the Plan is conditional on receiving required funding from DfT for 2022/23. At present, Transport East has not received confirmation of a settlement for future financial years.

The business plan sets out four key areas of work over the next three years which include:

- Become a leading English Sub-national Transport Body
- Plan the next generation of transport projects for the East
- Accelerate delivery of our transport projects in the East
- A Single Voice - put the East's transport priorities on the UK map

During this time TE will led on our commitments in the draft transport strategy, which include an integrated rail plan, detailed plans for electric vehicles, mass rapid transit, alternative HGV fuels, active travel, freight and rural mobility.

TE will expect to grow during the next year, with four new members of staff proposed. it was agreed that a 10% increase in LTA contributions for 2022/23 would be granted, and furthermore Transport East to launch an independent review of future funding options. This will include a review of district contributions for future years, in partnership with district reps. The review will be conducted early in the next financial year and their findings reported back to this Forum.

The Forum endorsed the recommendations in the paper, in addition to the following actions:

- Circulation of the job description for the new staff members (see below)
- A meeting to be arrange with the district leds before the review is undertaken

MRN / LLM Transport East Programme Review

Suzanne Buck and TESOG officers have led a review into the MRN / LLM programme for TE following the letter received from DfT on the 18th of January. The letter asked TE / LTAs to reconsider the schemes in the current programme, through the prism of:

- Reducing congestion
- Supporting economic growth and rebalancing
- Supporting housing delivery
- Supporting all road users
- Supporting the strategic road network

And more recently:

- Strategic case – does the scheme still meet the objectives of the MRN programme and/or the latest objectives/policies of the LA or STB?
- Value for money (VfM) – because of recent changes to Transport Analysis Guidance and other issues, is the scheme likely to be low or poor VfM?
- Timely progress – what progress has been made on the scheme since it was added to the programme in 2019 and will the scheme be ready to start construction by the end of the forthcoming Spending Review period i.e., March 2025
- Local support – is the scheme actively supported by the local MP(s) and others in the wider community

TE held meetings with all the LTAs to understand their current position. The Forum endorsed the paper submitted and the response has been sent to DfT.

Comments from members:

- Request to calculate the total funding we have saved DfT through the refinement/removal of some schemes in the programme since 2019, and the total costs that LTA have individually contributed to this process so far
- These schemes are critical to the region and emphasising the importance of them to Government is essential

Strategic Update

Network Rail

James Bradley provided a brief update on NR in the region. Key points were:

- Passenger numbers are at 90% of pre covid numbers
- The Anglian route is currently the best performing route in the country with all new stock rolled out
- WAML study has been published and can be found [here](#)
- NR is currently working with government to look at slippage and the scope for potential rail improvements across the region.
- Increasing Felixstowe capacity will unlock other areas of rail
- The call for evidence for the Whole Industry Strategic Plan has been completed, with TE response (in meeting papers) noted by Network Rail and the Great British Railways Transition Team (GBR TT).
- NR priorities for the region are set out the slides (see below)

Comments from members:

- The proposed electrification of both Thames Gateway and Felixstowe to connect with the mainline electrification is vital. It was confirmed these are in NR plans - both are within the top 10 locations for NR.
- A Rail Recovery Group is leading on the post COVID recovery for railway usage.
- Further engagement will be undertaken with STB on the formation and decision process of GBR TT. NR will be in touch to arrange meeting in due course.
- The capacity of the East Suffolk Rail Line for use in the construction of Sizewell C is being explored by NR and they are working with EDF.

National Highways

Nigel Allsopp summarised the National Highways work to date in the Transport East area. Route Strategies workshops have been held and responses are being collated with the first draft of the report to be shared with Transport East.

Further engagement workshops will be held in April to discuss these findings and the final report to published in late spring.
